## Bachelor of Arts and Sciences in Design+ Degree [BASc(Design+)]

#### Induction Programme

1. To provide all freshmen with essential information to ensure a smooth transition to your studies at the University, students are required to attend the induction programme which include the following events:

- a. Faculty Induction Talk will be held face-to-face on 14 August 2024 (Wednesday) from 10:00am to 12:00noon, at Room 223, 2/F Knowles Building, HKU.
- b. Programme Induction Talk will be held face-to-face after the Faculty Induction Talk on 14 August 2024 (Wednesday) from 1:45pm to 2:30pm, at Room 730, 7/F Knowles Building, HKU. During this Programme Induction session, the Department will go through the BASc(Design+) curriculum and other academic matters related to Design+.

#### Faculty Academic Adviser

2. To ensure that your transition to the University is going well, each new student will have an academic staff to serve as your Faculty Academic Adviser (FAA). Please sign up for your FAA from **2:00 pm, 12 August 2024 (Monday) to 10:00 am, 20 August 2024 (Tuesday)** at <u>https://ugaa.hku.hk/signup-faa.php</u>. If you do not sign up by 10:00 am, 20 August 2024, the System will randomly assign one to you.

Some quick notes:

- *How to sign up*: You will be directed to select from the list of advisers on a first-come-first-served basis.
- *Who is FAA*: FAA is a current teacher from your home Faculty who advises you on study-related matters.
- When to consult FAA: You are encouraged to approach your FAA whenever you need academic advice. Feel free to consult your adviser during the consultation hour (which can be found in your portal), or contact her/him by email to make an appointment.

## Course Selection and Curriculum requirements in 2024-25

4. All BASc(Design+) first year students are required to take the following courses in the First Year of studies in the 2024-25 academic year:

# The course taking pattern in respect of the Common Core courses and electives are recommended but not compulsory. Students may make adjustments where necessary with an objective to achieve a balanced study load of not more than 30 credits of courses in each semester and to fulfill the 24 credits of Common Core courses and 90 credits of elective courses requirements.

#### Notes:

1. The course list and course information above are subject to change.

2. Students are normally required to take not fewer than 24 credits nor more than 30 credits. Students may, of their own volition take additional credits units not exceeding 6 credits in each semester.

5. In order to satisfy the University/Faculty Graduation Requirements for the BASc(Design+) degree, all BASc(Design+) students are required to take 96 credits of Design+ major courses, 18 credits of BASc core courses, plus a total of 36 credits in language and Common Core courses, and 90 credits of elective courses, totalling 240 credits for the 4-year curriculum. Successful completion of any other non-credit bearing courses as required by the University forms part of the graduation requirements.

### English language requirement

6. To satisfy the English language requirement, student must take the following English language courses:

CAES1000 \* Core University English (Year 1) CAES9121 Communication course for architecture students (Year 2)

\* Note: Students who have achieved <u>Level 5 or above in the English Language in the</u> <u>HKDSE, or one of the equivalent qualifications as listed in Point 7 below</u>, are exempted from this requirement, and taking CAES1000 is **optional**. Otherwise, students are required to take CAES1000 as an <u>additional</u> 6-credit course to complete the degree studies (i.e. 246 in total).

7. The list of qualifications recognized as equivalent to achieving Level 5 or above in HKDSE English Language examination is as follows:

• holder of a Bachelor's degree from an English-medium university

- achieved Grade A or above in English Language GCE Advanced Level (AL)/ Advanced Subsidiary Level (ASL)
- achieved an overall IELTS score of no less than 7 <u>AND</u> with all sub-scores no less than 6.5 on the Reading, Speaking, Listening, and Writing Tests
- achieved an overall TOEFL Internet-based test score of no less than 94 <u>AND</u> no less than a 24 on the writing, a 20 on the speaking, a 20 on the listening, AND a 19 on the reading sections
- achieved in International Baccalaureate (IB) Grade 4 or above in English A1/ English Language A/ English A: Literature/ English A: Language and Literature (HL); or Grade 5 or above in English B/ English Language B (HL); or Grade 5 or above in English A1/ English Language A/ English A: Literature/ English A: Language and Literature (SL)
- achieved Grade 4 or above on the Advanced Placement (AP) English Language/ English Language and Composition/ English Literature and Composition Test
- achieved a NEW Scholastic Aptitude Test (SAT) score of 35 or above on <u>both</u> the Writing & Language Test <u>and</u> Reading Test (from 2016)
- achieved Grade B or above in H1 General Paper at the Singapore GCE A-level
- achieved Grade A or better in English language at Malaysia SPM examination
- achieved Grade A2 or better in Malaysia UEC-Senior English Language
- attained merit (3 points) or above in each set of credits in New Zealand NCEA Literacy (10 credits made up of 5 credits in reading and 5 credits in writing)
- achieved a score of 95% or better in English at All India Senior School Certificate Examination / Higher School Certificate
- achieved a final score of 90% or better in English at Grade 12 Canadian high school curriculum.
- achieved Grade B or better in English Language at Sri Lanka Ordinary examination
- achieved a score of 90 or better in English in the Russian Unified State Exam (Единый государственный экзамен, ЕГЭ, Yediniy gosudarstvenniy ekzamen, EGE)
- Academic Speaking and Writing test conducted by CAES for students who have not taken any of the above tests.

• When applying to take the Academic Speaking and Writing Test, students should provide evidence to their Faculties and the CAES1000 Course Coordinator that they were admitted to HKU using qualifications <u>other than</u> those included in the list.

• Applicants are required to show <u>the evidence of those other qualifications</u> to the assessor on the day of the Academic Speaking and Writing Test.

• If any applicants fail to provide any evidence that they were admitted to HKU using qualifications other than those included in the list provided by CAES, the CAES assessor has the rights not to allow the applicant to take the test.

• The test takes place annually in August. If a student fails to meet the application deadline, they will not have another chance to take the test, as no alternative test dates will be provided.

• The test is conducted face-to-face. There will be no alternative testing methods available for applicants.

#### **Please note that:**

• Optional students can only take the course during their <u>first</u> year of studies.

• JUPAS students with HKDSE English Language Level 3 or Level 4 are NOT allowed to use any of the above equivalent standards to get exempted from CAES1000.

• Non-JUPAS students\* are NOT allowed to use HKDSE results to get exempted from CAES1000.

• Test results (i.e., the above list\* and HKDSE) should be in the same year in which students are admitted to the University. Test results obtained after the admission to the University will NOT be considered.

\* Non-JUPAS students are allowed to use IELTS/TOEFL which is achieved within 2 years before admission to fulfil the English language requirement for admission.

\* Re-admitted students with combined HKDSE results with a level 5 or above in the HKDSE English Language examination, irrespective of the year they took the exam, will be eligible for exemption from CAES1000.

\* Students admitted through the School Nominations Direct Admission Scheme (SNDAS) are allowed to use results of HKDSE English Language Level 5 or above to get CAES1000 exemption. However, these students are not allowed to use any other equivalent qualifications to get exemption.

8. Except for students who have achieved Level 5 or above in the English Language paper in HKDSE, the exemption is subject to application and provision of the documentary proof. If you have fulfilled one of the above criteria, please write to <u>suslaw@hku.hk</u> or approach the Faculty Office (address: 4/F, Room 415, Knowles Building) directly with the original official copy/certified true copy of the relevant qualification by **15 August 2024**.

9. For students who are admitted to HKU using qualifications other than those included in the list above, they may apply to take the Academic Speaking and Writing Test if they wish to be exempted from taking CAES1000. Students who have been tested by the Centre of Applied English Studies to be of a standard equivalent to achieving Level 5 or above in English Language in HKDSE will be exempted from taking CAES1000. Students who are exempted will need to take an elective course in lieu. Please submit an application by email to suslaw@hku.hk on or before noon, 21 August 2024 if you would like to attend Academic Speaking and Writing Test scheduled for <u>26 August 2024</u>. Late submission will not be accepted.

10. Students who are automatically exempted from taking CAES1000 course (i.e., for achieving Level 5 or above in English Language in HKDSE) may, at their own wish opt to take the CAES1000 course. In this case, students do not need to take an elective course in lieu.

#### Chinese language requirement

11. To satisfy the Chinese language requirement, student must take the following Chinese language course which will be offered in the Semester 2 of the Second Year of studies:

CARC9001 Practical Chinese for Architecture and Landscape Students

For Mandarin/Putonghua-speaking students:

CUND9002 Practical Chinese and Hong Kong Society, or

CUND9003 Cantonese for Non-Cantonese Speaking Students

For all other students:

- (a) Take a 6-credit Cantonese or Putonghua language course offered by the School of Chinese for international or exchange students, or
- (b) Request to be exempted from the Chinese language requirement. If exempted, these students should take an <u>elective course in lieu of the language course</u>.

12. Please note that only those who have not attained HKDSE/GCSE level Chinese can apply for **exemption** from taking a **Chinese** language enhancement course as mentioned in paragraph 11(b) above. However, exemption will only be granted on a case by case basis and students who wish to apply for **exemption** of Chinese language enhancement course will have to submit their application to the Faculty Office (write to <u>suslaw@hku.hk</u> by **noon, 19 August 2024** at the latest. Please note, however, that those who have been granted an exemption of the Chinese language requirement are highly encouraged to take a 6-credit Cantonese or Putonghua language course offered by the School of Chinese for international or exchange students. The Faculty Office will <u>NOT</u> consider late application and any such application submitted in the Second/Third/Fourth year of studies.

13. Students will be notified of the application results through email.

## Course enrolment schedule

14. The course enrolment information system will be opened for freshmen to preview available courses after performing master registration. Please log in to the SIS Website via HKU Portal (<u>https://hkuportal.hku.hk/</u>) for access to the course selection system (SIS menu-> Enrolment->Enrolment Add Classes).

16. All undergraduates are required to complete their course enrolment via the online course selection system during the course selection period, from <u>10:00am, 20 August 2024</u> <u>until 4:00pm, 26 August 2024</u>.

17. Please note that the course approval method of Common Core courses (CCC) is on a *first-come-first-served basis* and quota is limited. To expedite the selection process, you may add the CCC that you wish to enroll in the shopping cart first and submit your request as early as possible once the course selection system opens. <u>Please avoid selecting a sub-class with the prefix "X" as this is for visiting/exchange students only</u>. For details of the course selection arrangements of CCC, please refer to the guide that will be sent to you from the SIS Office.

18. Please note that students are **not** allowed to:

- i. add/drop any Semester 1 courses/full-year courses after 4:00pm, **16** September 2024;
- ii. drop any Semester 1 courses/full-year courses during Semester 2;
- iii. change sub-classes of any Semester 1/full-year courses during Semester 2.

19. Students are urged to check their enrolment records via SELF SERVICE in the SIS as frequently as possible to ensure that their records are correct.

21. Dates for the add/drop period of **Semester 2** will be from **10:00am on 20 January 2025 to 4:00pm on 10 February 2025.** Students are NOT allowed to make any changes to their course selection during the suspension period, from <u>12:00 noon to 4:59pm, 21 January</u> <u>2025</u>.

22. Dates for the add/drop period of the summer semester courses will be from 10:00am on 16 June 2025 to 4:00 pm on 23 June 2025. There will be a suspension period during which students cannot have access into the system, from 12:00 noon to 4:59 pm, 17 June 2025.
